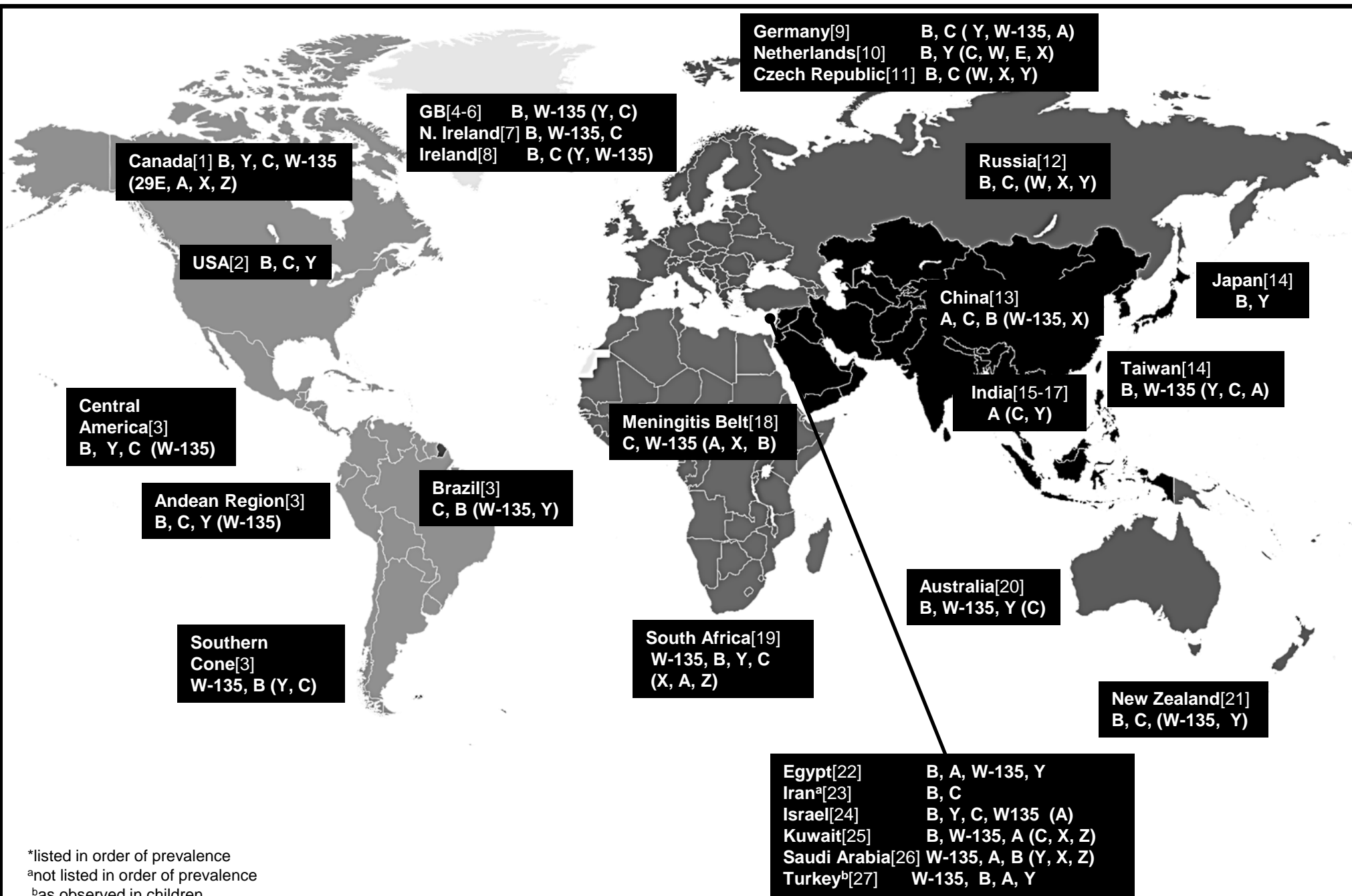


**Figure 1: Global Meningococcal Serogroup Distribution**
